**1-31 DAY EXCURSION RESTRICTIONS**

**Round trip Excursion** automobile tickets are honored for transportation of the **profiled vehicle** for travel starting in Vineyard Haven, Oak Bluffs and Nantucket. Tickets are valid for transportation on the reserved date off Island and the 30 following days to return to the Island. **Tickets must be used round trip.** The off Island portion of the ticket must be used for the return ticket to be valid. Tickets that have reservations are valid for the date on the ticket only, unless reserved space is changed 1 hour in advance. Tickets are valid for changes within the calendar year for which they were purchased. Fares include automobile, up to two adults and two children. The same car must make the round trip. **Only automobiles approved in the profile will be allowed to travel at the excursion rate.**

I also agree to abide by the policies relating to the resident excursion/preferred space and the HEADSTART programs. I understand that vehicle reservations I obtain under these programs are for my personal use as a resident of Martha's Vineyard/ Nantucket. I further understand that the only vehicle reservations that are transferable are the three that I designate as such on my HEADSTART application.

**If I do not comply with the associated policies, I understand that I may be denied participation in the HEADSTART program and will be denied access to preferred reservations and excursion rates.**
